Background Information about the Service

The Fostering Service has been in existence since 1980 and is the longest established Independent Fostering Agency in NI, recruiting, assessing,

approving and supporting carers to work with children and young people from 0-18 years. For the past 14 years, we have worked closely with Barnardo's Children's House successfully working with residential staff to recruiting carers and supporting young people moving on to permanent foster care.

During our 38 years in fostering we have worked with children and young people with a wide range of needs and developed particular specialism with children with disabilities and with complex attachment histories.

We have high foster carer and retention rates and as a consequence, provide many long term foster placements. Our service offers an established support and training package for all our foster carers.

Over the past few years, the service has expanded, currently providing placements across NI and working with each of 5 HSC Trusts. We are keen to continue to extend our reach so can offer flexibility in respect office location for potential applicants.
