Role

This role provides an important service to our shops by collecting, transferring, and delivering stock from one shop to another, thereby ensuring that stock is at the right shop, at the right time in the most cost and time efficient manner. This role will also be responsible for collecting stock from specific locations as requested and moving furniture within or across areas as required. Due to NI Hospice Motor Insurance requirements, minimum age to apply is 25 years with less than 6 points on licence.

Main Responsibilities

- Collection of stock and furniture items from one shop to be transferred to another shop within or across areas as required.
- Collection and delivery of furniture to and from private residences.
- Collection of bags and boxes of donations from private residences or workplaces as required.
- Navigate successfully to shops across NI.
- Must have: A full current driving licence. Able to carry and lift heavy bags of stock. This role
 is physically demanding and will require frequently lifting and moving heavy items of stock
 and furniture, often up and down stairs as premises dictate.
- Undertake regular tip-runs to dispose of relevant items.
- Assist in the warehouse when not collecting or delivering stock/furniture and undertaking any reasonable request by management.
- Proactively respond to management directives, demonstrating growth within the position and taking on additional responsibilities as part of career progression.





- Work collaboratively with shop teams to ensure stock supply maximises sales.
- Assist with the moving of shop fixtures and fittings as requested by management.
- Liaise with Management to arrange schedules for maximum efficiency.
- Map out transfer and stock routes for required stock in each shop.

Vehicle

- Responsibility of care and maintenance of Charity vehicle in accordance with NIH procedures.
- Ensure regular vehicle service intervals and cleaning routines.
- Travel where required using most cost-effective route.
- Drive with due care and attention, adhering to speed limits always.
- Utilise the vehicle management system in line with NIH procedures, compete daily vehicle checks and report any identified problems to Management.
- Drive different sized vehicles.

General

- Complete all health and safety requirements and demonstrate a duty of care regarding personal safety to yourself and others.
- Complete all admin/paperwork accurately and in a timely manner in accordance with requirements.
- Participate in and support continuous improvement plans.
- Complete all compulsory compliance training.
- Attend Manual Handling training ensuring your ability to fulfil the requirements of the role at the required pace.
- Demonstrate effective collaboration across the organisation, in line with best practice procedures and an authentic commitment to knowledge sharing and collective success.
- Undertake any other special projects or duties, which may from time to time be requested and which are commensurate with the duties and responsibilities of the post.
