Role Overview: Early Years Supervisor

The Early Years Supervisor plays a key role in the planning, delivery, and supervision of services for children aged 0–4 and their parents/carers. This



includes overseeing staff and ensuring the smooth operation of the following programmes:

Developmental Programmes for 2-Year Olds

• Children attend three 2.5-hour sessions per week (September–June)

• The Supervisor is responsible for day-to-day delivery, staff support, home visits, training participation, and maintaining service records.

Outreach Play Programmes

• For children aged 0–4 years

• The Supervisor leads the delivery of outreach play sessions and provides staff supervision and support.

Person Specification

Essential Criteria - Applicants must outline in their application how they meet the following:

• NVQ Level 3 in Childcare, Learning and Development or QCF Level 3 in Playwork or Childcare Learning and Development (or equivalent)

• Demonstrable experience working in a pre-school or outreach setting with 0–4year-olds

• Experience in communicating effectively with parents/carers regarding their children's needs

Desirable Criteria

• Experience supervising or supporting staff in a childcare setting

Additional Requirements

• A full current driving licence and access to a car are essential due to the wide geographical area of service delivery across Mid Ulster. (Applicants with a disability that prevents them from driving may provide evidence of alternative mobility arrangements.)
